They have approached the Municipality in relation to their intention to purchase that land, however they are not being assisted after several attempts. They were informed by Mr. Tefo who is in the employ of the Municipality to apply and further indicate the ERF numbers they are interested in. To date they have not heard a word from Mr. Tefo. She also alleges that in 2014 the residents of Soulcity were informed by Councillor Suzan Silaule that they would be relocated to Kagiso, ext.13 and a budget of R10 million had been set aside for this relocation. She further alleges that the planned relocation according to the Councillor was scheduled to take place in June 2015 but it did not take place. Furthermore, she alleges that the mayor Cllr Calvin Seerane had a meeting with community members in July 2015 and informed them that they would be relocated to Kagiso ext.13, Sterkfontein, Chief Mogale, Westonaria and Mulderdrift plot 39 respectively in December 2015, but the relocation did not take place.</p> <p>As a result, she alleges that the community members no longer want to move but instead want their area to be developed and for the municipality to provide basic services such as water, electricity and sanitation.</p>	<p>The petition was referred to Mogale City Local Municipality and the Gauteng Department of Human Settlements for investigation and reporting, and to the Portfolio Committee on CoGTA and Human Settlements and the Department of CoGTA for oversight on the <b>29<sup>th</sup> Feb 2016.</b></p>	<p>Awaiting Report</p>

Further to that, she alleges that the family was unable to move into the house as it was occupied by someone else.
